Loan Services

1. Machinery Loan

All State and Central Government Subsidies

1. Capital Subsidy

Capital Subsidy on the term loan is available to New MSME unit as well as existing units for expansion in Plant & Machinery and Factory Building from 10 % to 25 %.

2. Interest Subsidy

Interest Subsidy from 5% to 7% on term loan depends on the Taluka category available for manufacturing and service sector.

3. CLCSS subsidy

CLCSS is the Central Government subsidy for MSME units for purchase of new technology plant & machinery. 15% Capital Subsidy provided under the scheme.

4. CGTSME Subsidy

100 % reimbursement of annual fees paid to the bank or financial institution for availing CGTSME Loan for 5 years.

5. Electric Duty Exemption

New/Existing Industrial units are eligible to avail exemption from electric duty for 5 Years on the basis of electric consumption.

6. TUF/A-TUF Subsidy

Central and State TUF/A-TUF Subsidy is available to textile units engaged in Weaving, Knitting, Dyeing/printing, Technical textile, twisting, Machine embroiders and other eligible activities under scheme.

7. Agro and Food Processing subsidy

Capital & Interest Subsidy on Agro and Food Processing units, Cold Chain, Food Irradiation Processing Plants, Pack Houses is available.

8. MSE Shed Development Subsidy

Subsidy is available to Private developer for the setting Mini estate having area less than 2 Hectares / shed of 50 Sq. Mt. to 100 Sq. Mt.
